Neighborhood Revitalization One of our core strengths is identifying and building civic leaders who are capable of leading change in their neighborhoods. Using decades of experience in community building, we accelerate the speed of change for new community leaders. In 2016, we conducted Leadership Steering Committee meetings to engage community leaders in making decisions on the White Rock Hills Community Center design and programs. We also held an annual litter abatement to beautify the community. This is a fun project that instills community pride! We also promote local businesses at our community events.

4b (Code:) (Expenses \$ 1,727 including grants of \$ 0) (Revenue \$ 2,500)

Financial Services/Education For the past 11 years we have provided Volunteer Income Tax Assistance and Financial Education Network Literacy Programs to 7,876 individuals and families, and have kept more than \$13.5MM in tax refunds in the community. 60% of our families are Hispanic, with 50% speaking Spanish at home, 13% are African American, 19% Asian, and 8% White. In 2016, we served 1,403 families and returned \$2.7 MM to community residents.

Communication FRI has about 93,000 constituents, 2000 unique businesses, 60 apartment communities, 29 faith communities, and 35 neighborhood associations to keep informed. Multiple communication venues such as a news magazine, electronic newsletter, direct mail, and social media reach our broad audience. Venues include: Bi Annual Magazine, Bi Annual Town Hall Meetings, Annual Leadership Summit, Electronic News, Social Media and Community Fairs.
