Communication: FRI has 93,000 constituents, 2000 unique businesses, 50 apartment communities, 23 churches, 37 neighborhoods, 17 schools and more than 20 area nonprofits we keep informed on a regular basis throughout the year. Multiple communication venues such as a semi-annual news magazine (FRIdays), 2 x per month electronic newsletter (NewsFlash), direct mail, robocalls, and social media platforms reach our broad audience. Other venues include spring and fall town hall meetings, community fairs and special events.

Community-Building: FRI is a "backbone" organization whose key program is Community-Building. We provide ongoing support by guiding vision and strategy, raising funds, convening meetings, supporting aligned activities, establishing shared measurements, building public goodwill, communicating opportunities and results to constituents, advancing policy, and mobilizing resources. These services are helping our area nonprofits make a positive "collective impact". FRI works behind the scenes to ensure our partners are successful in fulfilling their missions. Our core strength is identifying and building civic leaders. We identify, train, and coach them so they can work collaboratively with their volunteers to solve their own problems.

4c (Code:) (Expenses \$ 10,598 including grants of \$ 0) (Revenue \$ 0)
Financial Services/Education: For the past 16 years FRI has provided support for the Volunteer Income Tax Assistance and Financial Education Literacy Programs to 14,735 individuals and families and have kept more than \$26,000,000 in tax refunds in the community. Over 60% of our families are Hispanic, 19% are Asian & Other, 13% are African American, and 8% are White. In 2020, over 40 volunteers donated 587 hours valued at \$15,967, served 875 families, and returned \$2,005,263 to community residents through their tax returns.
