MINUTES

Vikki Martin began the meeting at 6:50 pm with an introduction of staff, including new staff, Esther Romero (Membership/Special Events) and Susan Hopper (Communication/Marketing Director).

Emery Blackburn spoke on the City of Dallas Code Compliance.

Martin listed Founder's Circle donors and sponsors of our March 5 Beautification Cleanup including **Dan Micciche, Aspire, LIghtChurch, Michael & Janice Walkers, David Weekly Homes.**

Martin and Dan Ortman presented **DISD Trustee Dan Micciche** with an FRI Obelisk Award for his support of FRI and his service of improving the lives of children through education.

DALLAS POLICE DEPARTMENT REPORTS

DPD Chief Osama Ismaeil, Commander over Northeast Station reported:

- **Greater Casa View**: No changes in Overall Crime, Violent Crime up 17%
- Forest Hills/Casa Linda: Overall crime down 2%, Violent crime down 38%
- White Rock Hills: Overall crime up 31%, Violent Crime up 42%
- White Rock East: No change in Overall Crime, Violent Crime down 17%

Ismael offered the following to reduce crime:

- If you see something, say something.
- Be proactive regarding burglary prevention.
- Don't leave keys in car with motor running for quick convenience store shopping.
- Call the police if you see a suspicious person.
- Shut your garage door if you are going inside your home, even for a short time.

ELECTED OFFICIALS MADE ANNOUNCEMENTS and REPORTS

Kerry Goodwin (for **State Representative Jasmine Crockett, District 100**) spoke on Covid-19 prevention vaccination success outcomes.

County Commissioner Theresa Daniel, District 1, spoke on

- All of FRI community is still in District 1, after redistricting.
- The county tax rate is down slightly (lowest rate since 2011), but evaluations are up.
- Improvements on I-635E.
- Efforts to support trails.
- Purchase of electric county vehicles.
- Jail update, possible new location.

School Board Trustee Dan Micciche, District 3, spoke on:

- New DISD Superintendent.
- State Accountability ratings.
- 90% of DISD students are disadvantaged.
- Early college programs.
- 2020 bond projects at Bryan Adams School.
- Tour of Bryan Adams School at 6 pm on Wednesday, October12

City Councilmember Paula Blackmon, District 9, spoke on:

- Health center, clinic in District 9.
- More trail connections.
- Dredging of White Rock Lake at \$80M, possibility of intermittent silt removal.
- Ferguson Road Traffic Calming Study, currently in progress
- Highland/Ferguson Roads intersection design.
- 3035 Buckner redo still in progress.

City Councilmember Jesse Moreno, District 2, spoke on:

- Recently took tour of Ferguson Road area.
- His priorities include homelessness and economic development

OWENWOOD FARM & NEIGHBOR SPACE

Zach DeMoya, Executive Director, spoke on:

- Wanting OFNS to become a community center.
- Recently giving 20,000 lbs of food and diapers on one Saturday.
- Working with seniors and schools.
- Working with Creative Art Center on art classes.
- Creating a site for nonprofits.
- Operating a 4 acre urban farm.

TRANSFORMING DALLAS

Ken Benson spoke on:

- Voting for Proposition A on November ballot for 2% hike in hotel occupancy tax to fund Fair Park and Dallas Convention center projects.
 - Deferred maintenance issues regarding above.
 - o Prestigious events at risk.
 - Loss of convention business to other cities.
 - New Convention Center will be located in entertainment district in The Cedars area, linking South Dallas and downtown.
 - New Center provides jobs, tax revenue.

TRINITY FOREST SPINE TRAIL

Philip Hiatt Haigh, Executive Director of Circuit Trail Conservancy, spoke on:

- Creating a 50-mile-long loop trail.
- The TFST is one of 4 trail projects.
- The Glen Tenison Park Golf Course will reduce to a 9-hole course, providing room for the trail and a nature preserve area.
- Work with the Dallas Off-Road Bicycle Assn. on establishing mountain bike trails along the TFST.
- Need for a "Friends of Creekside" group. Contact Philip if you are interested: <u>philip@theloopdallas.org</u>
- Working on 501(c)3 nonprofit status.
- Having legal agreement with Dallas Park and Recreation Department to perform supplemental activities.
- Ability to advocate for additional capital improvements.
- TFST work will start by end of 2022, with ribbon cutting in the spring.

Dr. Theresa Daniels added that the County will provide partial funding for Ash Creek Trail, the connection trail linking Highland Road to St. Francis Park.

FRI BACKBONE ORGANIZATION

Susan Hopper, FRI Communications and Marketing Director, spoke on:

- Having a strong Board of Directors and Executive Director.
- Having a strong Mission Statement and Vision Statement.
- Consensus building, relationship building and resources mobilization.
- Measuring impact of efforts with Aspire success measurements.
- Vetting of proposals for the community and bringing public decision makers into the process.

- Communication with constituents.
- Raising funds for FRI and others.
- Having a collective impact.

NORTH TEXAS GIVING DAY

Vikki Martin said that NTGD is FRI's annual fundraising event.

Gary Garcia, VP Philanthropic Partnerships, Dallas Foundation, and resident of Claremont NA, spoke on why he and his wife give to FRI:

- Crime reduction through Weed & Seed efforts.
- The new library and park.
- The way FRI works with other groups.
- The fact that many communities have asked how can we get an FRI in our area?
- FRI is looking to raise \$50,000 through NTGD this year.
