


What is a Public Improvement District (PID)?

A PID is a special district created at the petitioned request of property owners and approved by City Council.

It is funded by a supplemental assessment that is paid with the annual property tax bill. These assessment funds are returned to the community to provide supplement services above and beyond existing city services.


A PID is focused on improving the quality of life in the community by enhancing public safety, improving and beautifying the community.

*****PIDs are governed by Chapter 372 of the Texas Local Government Code and the City of Dallas PID Policy





Ferguson Road Initiative

Far East Dallas Target Area







The FEDPID assessment rate will be \$0.12 per \$100 of assessed value. The rate may fluctuate annually, up to a maximum of \$0.15. Although FEDPID is expected to maintain a consistent rate year to year.

FEDPID Assessment Timeline

Late July	City receives certified tax values from the County
Aug-Sept	City confirms properties within PID and submits assessment roll to County
October	Assessment notices mailed with regular property tax bills
January (or sooner)	Payments due; same schedule and penalties as regular property taxes








FEDPID Benefits
